### **TATRACHEMA Production Cooperative**

The history of TATRACHEMA dates back to 30th October, 1945, when a group of 19 private individuals submitted the notification on the foundation of a new company in the form of the so called "FOUNDATION PROSPECT" to the Regional Court of Justice in Bratislava. The establishing General Assembly meeting held on 9th November, 1945 approved the first Articles of Association, pursuant to which the company was named UNIOSA – Association for the production and trading in soap, cosmetic articles and chemical-technological products, Limited liability co-operative based in Bratislava. Twelve persons entered into the UNIOSA co-operative and contributed 175 membership shares, each in the value of Kčs 5.000,-. These funds represented the basis for the development of future business activities.

In September 1946 the Trade Confederation accepted the UNIOSA co-operative as its first chemical co-operative member. The name UNIOSA remained unchanged until the extraordinary General Assembly held on 29th October, 1951 in Bratislava, at which the new business name TATRACHEMA, Production Co-operative s.r.o. (Ltd.) in Bratislava passed.

Currently, the economic management as well as the seat of the Trnava-factory are located in Trnava. In this factory the household chemistry products, such as WC cleansers, textile treatment agents, detergents, furniture and floor treatment and polishing agents, car cosmetics and body cosmetics are produced. The trade marks such as FIXINELA, DIAVA, BONY, SIFO, TORO, GRILPUR look back at years of loyal services provided to their customers.

The second factory is seated in Šaštín Stráže. The products of this factory include powder cleansers such as CITRA, TENY, FIXINELA, water softening agents – LUXON- crystalline and caustic soda, air-trap cleanser – SIFO, washing detergents and stain removers produced under the JASO brand, LUXON scale remover, etc.

Furthermore, the wholesale and retail stores located in Trnava offer the customers, besides the Tatrachema products, also further wide assortment of products made by other companies.

Tatrachema has the certificate of quality management system according to STN EN ISO 9001: 2009 and STN EN ISO 14001: 2005. All our products comply with the EU technical requirements.

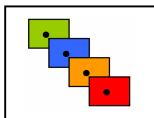
